## What is the NANC?

---

- A federal advisory committee (FAC) chartered under the Federal Advisory Committee Act (FACA).
- Members have been selected to balance the expertise and viewpoints that are necessary to address effectively the issues NANC will consider.
- *Charter Expiration Date*: September 18, 2019
  - FCC can seek to renew the charter for two more years.

## What is NANC's Mission?

---

- The Council's mission is to recommend to the Commission ways to modernize administration of the NANP in order to ensure the efficient, impartial assignment and use of vital numbering resources in the changing, modern world of communications.
- As authorized by FACA, the Council is authorized to facilitate its work through informal subcommittees, or other subgroups of the Council, which will report their activities and recommendations to the Council as a whole.
