The Working Group Chairs, in coordination with the NANC Chair, should make recommendations to the FCC on Working Group membership appointments as soon as possible. Membership in each Working Group must be limited so as to avoid having more than half of the full NANC membership on any working group. Therefore, we anticipate sending emails to the full NANC membership to ask each member to specify his or her top choices for Working Groups. We will share any responses with you and the Chairs. We note, however, that while those NANC members not appointed to Working Groups would still be able to attend meetings as observers, only appointed Working Group members may vote or debate matters considered by the Working Groups.

The Working Group Chairs may recommend members for their Working Groups, and you may make membership recommendations for all the Working Groups. After receiving these recommendations, we will review them to ensure that each Working Group has a balanced stakeholder membership, and also to ensure the appointments do not exceed a quorum of NANC members. We will then approve or modify the membership selections. Please note that, consistent with the requirements of the Federal Advisory Committee Act, Working Group members who are not members of the NANC must complete the ethics screening conducted by the Commission's Office of General Counsel in order to be an appointed member of a NANC Working Group.
