Re: Telcordia Dispute Resolution Team: Schedule for Consideration

On July 7, 2009, in order to provide the full NANC with a complete record and recommendation for resolution of the dispute request filed by Telcordia Technologies Inc. on May 26, 2009, you created the Dispute Review Team consisting of you, myself, and Don Gray of the Nebraska Public Service Commission Staff. In your July 7, 2009 memo you charged the team with five specific tasks; "review the complaint, interview participants, summarize findings, and draft an initial report and recommendation for the NANC's consideration." To accomplish this charge, we will proceed with the following schedule:

July 16	Team provides Status Report at full NANC Meeting (Washington, DC); on-the record interviews begin and continue through August
July 31	Written Comments and Responses on legal and factual questions raised by Telcordia due to Dispute Resolution Team
September 1	Target date for circulation of draft report to full NANC by the Dispute Resolution Team
September Sep/Oct.	Public and NANC members provide written response to draft report NANC considers report and recommendation at open meeting; NANC Chair finalizes and submits report and proposed resolution of the disputed issue to the Wireline Competition Bureau for public notice

The interviews will be focused entirely upon the facts and will be on the record. We intend to take notes of these factual interviews, provide a draft of those notes to interviewees for their review and correction, and promptly post the final notes of all interviews on the NANC Chair web page. Similarly, all written comments and communications will also be posted and made publicly available. All such information will be posted on www.nanc-chair.org/docs/dispute.html.
